



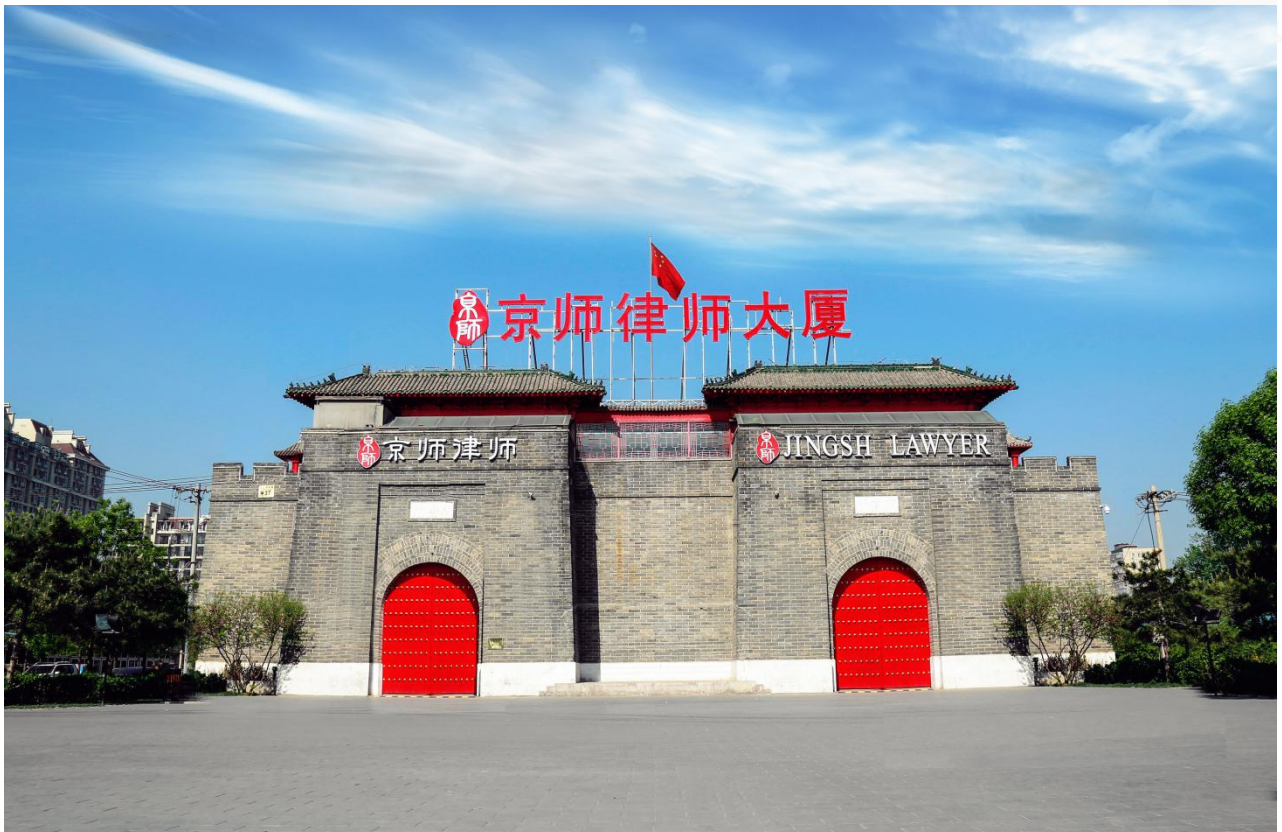

PREFACE

With the outbreak and continuous escalation of COVID-19 around the world, there is a serious shortage of epidemic prevention medical supplies (mainly medical devices), such as surgical masks, protective clothing and detection kits. China has gradually controlled the spread of COVID-19, and it is continuously restoring and increasing the production capacity of related epidemic prevention medical devices. In order to cope with international demands for epidemic prevention medical supplies and quickly purchase of qualified epidemic prevention medical supplies, we design and launch this tailored service project for global clients.

I Provide Comprehensive Due Diligence Work on Suppliers of Epidemic Prevention Medical Supplies

2. Investigating production capacity and supply capacity of suppliers, including but not limited to:

2.1 Whether the raw materials needed for the production of epidemic prevention medical supplies are sufficient;

2.2 Whether the labor force can cope with the production demands, and the quality and number of technical and quality control personnel;

2.3 Whether production lines can meet the order demand;

3. Investigating supplier's production environment, including but not limited to:

3.1 Aseptic workshop standards

3.2 Technical standards on disinfection and sterilization of epidemic prevention medical supplies

3.3 Requirements for production workers and technical and quality control personnel

II Drafting and Reviewing Sales Contracts for Epidemic Prevention Medical Supplies

1. Providing comprehensive contracts drafting and reviewing services for goods sales, including but not limited to terms governing products quality and use, transportation and delivery, force majeure, applicable law and dispute resolution, etc.

2. Conducting a thorough special research on relevant international conventions, international trade practices, private international law rules, domestic relevant foreign laws and regulations, and applicable cases in the export of epidemic prevention supplies. Offering consulting and advice on laws and policies on international trade, customs, commodity inspections, taxation, quality, and producing necessary legal opinions herewith. Locating Suppliers of Epidemic Prevention Supplies that Meet International Standards and Certifications

1. According to the Announcement No. 5 of 2020 by the Ministry of Commerce of the People's Republic of China, the General Administration of Customs of the People's Republic of China, and the National Medical Products Administration of the People's Republic of China – titled *Decree Announcement on the Orderly Development of the Export of Medical Supplies*, helping to select and locate production companies that meet the requirements as from the list of companies that have obtained the registration certificate of medical devices in China.





2. Matching for different importing countries or regions with respective qualification requirements, against medical supplies companies that meet their standards. For example, the FDA requirements in the United States of America, the CE standard in EU region, the PMDA standard in Japan, the KF standard in South Korea, etc.

Part Four: Legal Services on Disputes Resolutions of the Procurement of Epidemic Prevention Medical Supplies from China



We understand so far there has been emerging a number of disputes concerning the import and export of epidemic prevention medical supplies, including disputes and possible litigations arising from the non-compliance with the entry standards of the importing country/region.
